RESOLUTIONS

I. <u>To confirm the minutes of the last meeting of the Academic council held on 01-08-2016</u>:

The Principal explained to the members about the minutes of the last meeting of the Academic Council.

II. <u>Scrutinization and Approval of UG and PG (MBA&MCA) Academic Regulations (R18)</u>:

The principal proposed the R18 academic regulations of B.Tech, MBA & MCA and some amendments comprises to R16 regulations. The committee accepted and approved the R18 regulations and differ the amendments of B.Tech R16 regulations.

1. Clause 4.3 Discussion on 4.7 of R16 regulations:

Existing: There shall be two comprehensive online examinations, one at the end of the II year II semester and the other at the end of III year - II semester, with 100 objective questions for 100 marks on the subjects studied in the respective semesters.

Proposed: In III-II semester along with Online Comprehensive Test we introduced MOOCs online course. Student can choose either Online Comprehensive Test or MOOCs course for one credit.

Decision of the committee: The committee members are not accepted for this proposal

2. Existing (R16 regulations): There is no open Electives in B.Tech Programme:

<u>New Proposal</u>: We proposed to implement Open Electives, in (OE -I) in III year II semester, and one open elective (OE-II) in IV year I semester, in place of one core Electives in the respective semesters.

Decision of the committee: The committee members are accepted for this proposal

III. Scrutinization and approval of MBA, MCA course structure, III & IV year of R16 and I & II year of R18 course structures of B.Tech for the academic year 2018-19 onwards

The committee approved of course structure of B.Tech, MBA & MCA programmes

IV. Scrutinization and approval of the syllabus which was discussed in Board of studies for each department of MBA, MCA, B.Tech I & II year of R18 regulations and III & IV year of R18 regulations

The committee approved the syllabus of B.Tech, MBA & MCA programmes..

V. To approve the constitution of Results committee and Moderation rules
