Item No.17 Other important issues

The principal put the following important points before the members for approval.

- a) The APSCHE released the guidelines for introducing new course structure for I year B.Tech students from the academic year 2020-21. The College Academic Committee also followed the guidelines in framing R20 with minor and honors degree.
- b) A Special Moderation in Evaluation system: In any subject if the pass percentage is below 40%, then special moderation is considered by taking 0.75% of maximum marks of all theory subjects offered in that semester, if any theory subjects and to all needy students.
- c) Challenging Valuation: Any student can apply for challenging valuation by paying fee of Rs.5,000/- per subject. If any change in the evaluated marks as 12 mark and more difference, the partial amount Rs.2000/- will be refunded to concern student.
- d) Issue of photocopy of Answer Script: To maintain r transparency, it is decided to issue photocopy of Answer Script to the candidate for a payment of Rs.1000/- per answer script.
