Item No 1: Implementation report on the minutes of the last meeting of the Academic Council held on 27.01.2021

Dean Academics appraised the members about the previous Academic council meeting held on 27.01.2021 and presented the implementation report.

- Academic Regulations & Syllabus of R20 for B.Tech and M.Tech were successfully implemented during the academic year 2020-2021.
- Meetings of Boards of Studies were convened for all the departments
- Research publications in indexed journals were increased to greater extent.
- The duration of class changed from 50minutes to 1Hour to improve the effectiveness of the class, Number of tutorial hours also included as and when required.

Placement Package needs to be improved and students need to be motivated towards becoming Entrepreneurs.


Interaction with industry needs to be improved, Industry designed courses need to be added in the curriculum.
